40th LAKSANA REPORT

IMPLEMENTATION OF BUDGET 2021, PERMAI, KITA PRIHATIN, PENJANA AND PRIHATIN

10 February 2021

INTRODUCTION

- 1. We meet again for the 40th LAKSANA Report. I hope everyone out there is safe at home, or at the office for those who are still allowed to work in the office. Amidst this pandemic, do continue to our maintain our discipline in self-care in your daily life.
- 2. This report will start off with a review on current issues, followed by the status of implementation of key Government initiatives namely PERMAI Assistance Package, Budget 2021, PENJANA Economic Stimulus Package, and KITA PRIHATIN Assistance Package. The ongoing implementation status of the PRIHATIN Package initiative can be referred to in Appendix 1.
- 3. Before I begin this 40th LAKSANA Report, allow me to recap that the Ministry of Finance's initiatives, including the 2021 Budget, revolve around three main themes i.e., People's Welfare, Business Continuity and Economic Resilience. Recently, this approach was further expanded through the PERMAI Assistance Package designed to expedite and expand the scope of delivery, as well as increase allocations, where necessary.



4. This is the Government's role - to ensure that all financial and material needs are available. The good news is that the 2021 Budget and PERMAI initiatives have already begun, and I would like to share the benefits of these initiatives that touch on various aspects of our community.

BUDGET 2021 & PERMAI ASSISTANCE PACKAGE

A. Managing the COVID-19 Pandemic

- 5. The priority for us now is our effort to alleviate the impact of COVID-19. In this regard, I urge all parties to not compromise on violations of, or non-adherence to SOPs. The Ministry of Health's COVID-19 screening capability has also been enhanced. As of February 5, nearly 1.2 million tests have been conducted with a cumulative total of over 6.4 million tests.
- 6. The 2021 budget also allocated RM1 billion additional funding and allocation focused on supplies such as additional reagents and screening kits, as well as PPEs especially for health workers. We hope that with the increase in screenings, following instructions to employers to conduct screening tests on their employees, we can identify those with symptoms faster, enabling speedier isolation to curb the spread of the pandemic.
 - 7. Although employers have to bear the cost of the COVID-19 screening, the PERMAI Assistance Package allows them a double tax deduction for that cost, while SOCSO will cover the cost of screening foreign workers in red zones. This tax exemption incentive is also enjoyed by individuals for COVID-19 screening expenses.
 - 8. Through the PERMAI Assistance Package's additional allocation of RM3.25 billion for 2021 to address the COVID-19 pandemic, the Ministry of Health has also applied to the Public Service Department to increase their number of health workers by 11,280 to address the COVID-19 pandemic and maintain their service quality. Equally important is to safeguard the frontliners' well-being. To this end, the PERMAI Assistance Package has also approved the recruitment of 3,500 health workers beginning end-January 2021.

B. National Employment Council: 500,000 New Job Opportunities

- 9. The Government acknowledges the 4.8% unemployment rate for December, which is the same for November 2020. However, what is more important is the Government's efforts in generating economic growth and 500,000 job opportunities in 2021, despite the highly challenging environment. This increase in the number of health workers can also be considered as one of the Government's initiatives to create new employment opportunities in the 'critical employment' category.
- 10. In this regard, the **National Employment Council**, which met for the second time on February 9, has estimated that more than 160,000 new jobs will be created in 2021



through committed investments, InsyaAllah. It is hoped that through the joint efforts of all parties involved, the unemployment rate of 4.8% recorded at end-December 2020 can be reduced in the coming months, especially with the Government's ongoing efforts such as the MyFutureJobs portal (https://www.myfuturejobs.gov.my/) and the Ministry of Human Resources' e-LATiH platform (https://latih.hrdf.com.my/).

C. Social Security

- 11. We are also pleased to announce that the PRIHATIN MySalam initiative (http://mysalam.com.my/) has approved 67,000 COVID-19 related claims, with a total value of RM35 million as at end-January 2021. As announced in the PRIHATIN Package, mySalam hospitalisation benefits for coverage of RM50 per day for a maximum period of 14 days have been extended to those admitted into hospitals due to COVID-19, or instructed to quarantine either at MOH quarantine centres or at home.
- 12. The Government notes the encouraging response to the MySalam scheme, as a form of social security net for about 8 million low-income and differently abled people. The scheme covers the treatment for 45 critical illnesses, and reflects the Government's commitment to the people's well-being, especially in dealing with COVID-19 infections at present.

PENJANA (National Economic Recovery Plan)

Ladies and Gentlemen,

13. I will now review the PENJANA Package as of 29 January, 2021. This package is based on three objectives, namely **Empowering the People**, **Propelling Businesses**, and **Stimulating the Economy**.

PENJANA OBJECTIVE 1: EMPOWERING THE PEOPLE

14. First, touching on the Objective of Empowering the People, the Phase One Wage Subsidy Program (PSU 1.0) is still ongoing. The program has achieved a distribution value of RM12.757 billion for 322,177 employers and 2.64 million registered employees.

15. Second, the Hiring Incentive and Training Assistance Programme. A total of 130,828 employees have secured employment through this program (compared to 129,901 employees in the previous week). Manufacturing as well as wholesale and retail trade are among the key industries and sectors that employ workers. 16. **Third, Reskilling and Upskilling Programme.** There was an increase to **133,301** participants in the programmes provided (an increase of 348 from 132,953 individuals in the previous week). The Ministry of Finance site lists the courses in demand, and those who are interested can visit the websites of the respective Government agencies involved to obtain the relevant information.

PENJANA OBJECTIVE 2: PROPELLING BUSINESSES

- 17. PENJANA's Second Objective is Propelling Business.
- 18. First, the TEKUN Business Recovery Scheme (TBRS) specifically for Micro SMEs with a fund of RM100 million has achieved its objective by benefitting 14,946 Micro SMEs. At the same time, there are still financing initiatives available under this Objective such as the PENJANA SME Financing and PENJANA Tourism Sector Financing, which caters to SMEs as well as micro SMEs.
- 19. Second, PENJANA SME Financing. The Government's allocation of RM2 billion under this program prioritises SMEs that have never obtained bank loans. A total of 6,507 applications were approved with a total loan value of RM1.231 billion.

- 20. Third, PENJANA Tourism Sector Financing. Government allocation of RM1 billion is for SMEs and Micro SMEs still impacted by COVID-19. As of 29 January, there were 573 applications for this financing and of this total, 277 applications have been approved with a total financing of RM55.4 million. - 21. **Fourth, Bumiputera Relief Financing (BRF)**, which was introduced by Perbadanan Usahawan Nasional Bhd (PUNB) with a fund of RM200 million, from which **519 SMEs** have received funding of **RM143.8 million** (compared to 494 SMEs receiving a total of RM135.5 million in the previous week). PENJANA OBJECTIVE 3: STIMULATING THE ECONOMY

Ladies and Gentlemen,

22. For PENJANA's third objective of **Stimulating the Economy**, this week's report focuses on **service tax exemption for hotels** up to 30 June 2021, to support the tourism sector. The value of tax exemption utilised by hotel and accommodation operators has touched **RM1.37 billion** (an increase of RM533.42 million compared to RM836.56 million in the previous week). Among the initiatives to support the tourism sector are individual tax relief up to RM1,000 on travel expenses, as well as full exemption on tourism tax for foreign tourists.



23. In this regard, a few days ago, the **Governments of Malaysia and Indonesia had** agreed to create a travel bubble to boost the tourism industry in both countries. The Ministry of Finance welcomes this initiative, and when combined with the funding allocation for the tourism industry, I hope that those from the industry will be able to recover, InsyaAllah.

KITA PRIHATIN (Kerangka Inisiatif Tambahan Khas PRIHATIN)

Ladies and Gentlemen,

24. Under KITA PRIHATIN, for the Phase Two Wage Subsidy Programme (PSU2.0), a total of RM741.16 million has been channeled to 64,345 employers to enable them to continue operating and maintain 518,793 employees. As stated during the 2021 Budget, targeted wage subsidy programmes were also introduced to assist the tourism and retail sectors, while all sectors affected by the implementation of MCO this year are eligible to receive PSU 3.0 support under the PERMAI Assistance Package.

This special allowance e is also extended to members of the military, police, customs, immigration, firemen, members of the Civil Defense Force as well as RELA members who are directly involved in implementing the Movement Control Order (MCO).

As of **29 January 2021**, the total number of applications approved by local banks and approved by SMEs is **RM11.60 billion** which will benefit **24,613 SMEs**. This amount includes Special Relief Facility (SRF), Automation & Digitalisation Facility (ADF), All-Economic Sector Facility (AES) and Agrofood Facility (AF) funds.
